Below is a schedule of Canadian equivalent amounts found on an ATA Shoot Financial Report. As always, you have the option of collecting in U.S. funds. If you are submitting payment to the ATA in U.S. funds there is no need to make the conversions below. However, in order to assist in your shoot entry, we will accept the following Canadian equivalents by check:

| Trap & Field Subscription (Discount when pd with dues or life member) | \$30.00               | \$40.50                        |
| Trap & Field Subscription (No discount if pd separate from dues)      | \$35.00               | \$47.25                        |
| Add if Trap & Field Sub. is mailed outside the USA                    | \$15.00               | \$20.25                        |
| Average Book  | \$12.00               | \$16.20                        |
| Add if Average Book is mailed outside the USA                         | \$6.00                | \$8.10                         |
